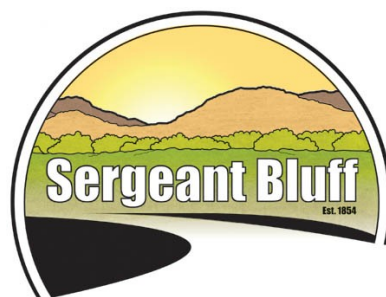


# You're Invited to Participate
