Operation of All-Terrain Vehicles are allowed only by being registered with the DNR in Sioux City, possessing a valid driver's license, registered with the City of Sergeant Bluff, must be a person 16 years of age or older and if under the age of 18 must have a valid ATV Education Certificate.

It is the responsibility of the vehicle owner to have valid proof of DNR ATV Permit, to include permit affixed to ATV at time of registration. The registrant/applicant is responsible for any other individuals who may drive the ATV.

The vehicle owner is to maintain liability insurance on the vehicle and to be able to prove such liability is in force at all times.

I also understand that it is my responsibility to comply with all rules and regulations regarding the operation of All-Terrain Vehicles upon City streets as set by the City of Sergeant Bluff and the State of Iowa Code Chapter 321I.
