- 1:30 pm** Whoever can eat an entire pie the fastest wins! No hands may be used, and pie plate cannot leave the table.
- 2:00 pm** Let's Hear That Whistle! The person to eat 8 saltine crackers and then whistle first wins!
- 2:30 pm** Tip the Can. There will be a tennis ball placed in a pair of pantyhose. The pantyhose will be placed in the rear waistband of the contestant. The contestant will swing the ball to knock over 10 water bottles. The first person to knock over all 10 wins!
- 3:00 pm** Oh Oh Oreo - Who can stack the most Oreo's on their forehead while sitting down and tipping head backwards. The most Oreo's stacked in 5 minutes wins!
- 3:30 pm** Watermelon eating contest
