I understand insurance regulations prohibit wheeled vehicles, excluding wheelchairs, but including bicycles, skateboards, etc. I assume all risks associated with running or walking in the event - including, but not limited to, the following: falls, contact with other participants, effects of weather (rain, heat, and/or humidity), traffic and condition of the road - all such risks being known and appreciated by me. I understand organizers and sponsors of this activity are not liable for any injury resulting from my participation. Having read this waiver, knowing these facts, and in consideration of my voluntary participation, I, for myself, and anyone acting on my behalf, waive and release Community Action Team and all sponsors, representatives, or other involved, for any and all present and future claims or liabilities of any kind arising out of my participation in this event.
