Public Hearing – Variance – Sign in an Easement

A Public Hearing was scheduled to consider a variance application submitted by Sioux City Brick/Glen-Gery on behalf of NAIU United for the easement adjacent to parcel 884730402002, described as BLAIRS ADDN LOT 5 BLK 4, more generally known as 504 S Lewis Blvd S in Sergeant Bluff. The easement is approximately located at the NE Corner of Fifth Street & Lewis Blvd

A motion was made by Lindberg, seconded by Johnson to open the public hearing at $5:34\ pm.$

A letter was provided by Mark Huntley, Public Works Director which stated:

"I am writing this letter in support of Sioux City Brick. The company would like to place a sign in the city right-of-way to let truck drivers and customers know where to correctly enter their compound. The signage at the corner of 5th and South Lewis is an area that will not interfere with the city utilities or line of sight for intersection traffic. Sioux City Brick has made several improvements requested by the city, since being under new ownership. I feel this would be another great step in cooperation between the city and our local businesses.

Mick Koenck, Plant Manager, attended on behalf of Sioux City Brick/Glen-Gery. He believed that having the sign in this location would help truck traffic coming through that area and prevent congestion on City roads from misdirected vehicles.

The variance is to permit a sign in the easement adjacent to parcel 884730402002, described as BLAIRS ADDN LOT 5 BLK 4, more generally known as 504 S Lewis Blvd S in Sergeant Bluff. The easement is approximately located at the NE Corner of Fifth Street & Lewis Blvd.
